In continuation of this office order No.201/PRC Fin-1988 dated 3-5-90, the Punjab State Electricity Board is pleased to order that the employees who are in receipt of special pay, shall continue to draw that special pay on their placement in the Time Bound Promotional Scale/Devised Promotional Scales, where the employee continues to shoulder the same duties and responsibilities of the post for which special pay has been sanctioned for arduous nature of duties, subject to the following conditions :-

1. The element of special pay will not be taken into consideration at the time of fixation of pay on actual promotion.
2. There shall be no claim for protection of emoluments, in case pay fixed on actual promotion happens to be less than that pay + special pay being drawn under 9/16 scheme.
3. There shall be no claim for anomaly by those actually working on higher posts, in case the pay of those not promoted but get higher pay by virtue of the benefit of being allowed to draw special pay alongwith next higher scale.

In continuation to office order No. 675/Reg-Loose-73 dated 13.10.89, the Punjab State Electricity Board is pleased to add following notes below Regulation 20 of PSEB MSR Vol-III(T.A. Regulations):-

Note-1

Officers of Grade-I & II drawing pay of Rs. 3000/- and above may draw mileage allowance by road for all journeys on tour made by own car/motor cycle/scooter subject to non availability of Board's vehicle and further subject to condition that some real public interest viz. inspection of works enroute or saving of time is certified by the Controlling Officer. No Divisional Officer will be entitled to perform journey in his own car. They should perform the journey by the Jeep provided to them.

Note-1(a)


PSEB employees of Grade-III are not ordinarily expected to perform journeys by motor car and accordingly for such journeys they should not draw mileage in excess of the rate prescribed for other means of conveyance. The mileage allowance for motor car can only be drawn by such employees when it is certified by the Controlling Officer concerned that it was absolutely necessary in the public interest that the journey should have been performed by a motor car.

2. The Punjab State Electricity Board is further pleased to decide that Note-1 already given below Regulation-20 ibid be re-numbered as note-2 and may be read as under:-

"The PSEB Grade-I, II & III employees may be reimbursed actual taxi fare instead of local mileage allowance @ Rs. 1.75 per KM subject to the production of a certificate by the touring officer to the effect that he actually hired the taxi and paid Rs. _____ as taxi charges.

The notes 2, 3 and 4 already given below regulation-20 of Regulations, ibid will be re-numbered as Notes 3, 4 and 5 respectively.

4. This will take effect from 1.12.88.

Sub:- Grant of Travel Concession to Pensioners.

- 0 -

I am directed to invite a reference to paragraph 9 of Punjab Government letter No. 1/15/89-1FPIII/8078, dated the 31st August, 1989, issued by this Department vide which the State Govt. Pensioners were granted Travel Concession equivalent to one month's basic pension on completion of every block of two years with effect from 1st January, 1989 payable in the month of January of the year succeeding full two years after retirement of the pensioner concerned and to say that it has been brought to the notice of the Government that some of the pensioners who has completed their first block of two years after retirement upto 31.12.1988 and 31.12.1989, to whom the payment on account of Travel Concession was required to be made in January, 1989 and January, 1990 could not draw this payment due to one reason or the other.

2. With a view to facilitate the payment of Travel concession to the eligible pensioners, the President of India is pleased to decide as follows:-

- i) that those pensioners who had completed their first block of two years upto 31.12.1988 and 31.12.1989 shall be allowed to receive the payment of Travel Concession upto 30.6.1990;
- ii) that those pensioners who have received the payment on account of Travel Concession on the basis of unrevised pension shall be allowed to get the difference if any which may become admissible to them due to upward revision of their pension retrospectively.
- iii) that in future, the pensioners shall be allowed to receive payment on account of Travel Concession whenever they draw pension for the month of December (Payable in January) after completing the first block of two years after their retirement.
