I am directed to invite a reference to circular letter No. 4/7/92-FPI/2720 dated the 27.3.1992/11.10.94 on the above subject and to say that keeping in view the recommendations of the Fourth Punjab Pay Commission, it has been decided that the incentive for promoting small family norms, will be in the form of 'Family Plan Allowance' instead of Personal Pay. Consequently, no House Rent allowance/Rural Area Allowance or any other allowance will be admissible on the incentive.

These orders will take effect from 1.9.97, but no recoveries for the period 1.9.97 to 31.8.99 of any amounts received by an employee on account of house rent allowance/rural area allowance on the amount of such allowances shall be made.
