Subject: Commencement of works in absence of sanction to detailed estimates.

Regulation-6.8 and 6.9 of PSEB Manual on Capital Expenditure & Fixed Assets require that no work should be started unless a detailed technical estimate has been sanctioned, provision of funds made and orders for its commencement issued by the competent authority. These instructions were reiterated vide this office memo No. 163801/4681/1/40/FB-83-84 dated 31.12.1983 and 61882/62983/1/40/FB-83-84 dated 25.3.1988 and it was desired that the Divisional Officers should take immediate steps to get the estimates sanctioned at the most within 1/2 months where the estimates are to be sanctioned by the SE/CE.

It has been observed that unsanctioned estimates are still being operated which has been viewed seriously. It has now been decided that all the unsanctioned estimates should be got sanctioned from the competent authority by 30.9.1989 & no expenditure is incurred or payments made against works where the estimates remain unsanctioned beyond 30.9.1989.

The Chief Engineers shall ensure compliance of these instructions & shall report the default on the part of field officers to this office (Service Branch) for

initiating disciplinary action. In case of emergency, CEAs may authorise, in writing, payments against works in anticipation of sanction to detailed estimates, for an initial period not exceeding three months, by when the estimate must be got sanctioned.
