



Pay range for the employees who are in receipt of pay in the existing un-revised scales shall be the same as defined in paragraph-2 of this office order No. 398/Fin-38/Vol-VI dated 30.3.87. As regards the employees who have since started drawing pay in the revised scales of pay under the Punjab State Electricity Board(Revised Pay) Regulations, 1988, the pay range shall be on the basis of their pay as defined in Regulation 2.45(1) of PSEB MSR Vol-I, Part-I, which is commonly known as "basic pay".


