Subject:- Implementation of the recommendations of PSEB Pay Revision Committee-fixation of rates of rent for Board employees and grant of H.R.A.

Please refer to this office order No. 135/Fin/PRC-1988 dated 5.1.89 and No. 142/Fin/PRC-1988 dated 7.3.89 vide which the rate of rent to be charged from PSEB employees allotted Board's accommodation has been fixed in the revised scale of pay and also House Rent Allowance to be granted in the revised scale of pay.

2.- A clarification has been sought for from this office as to whether special pay is to be included in the basic pay while recovering the rent for Board's accommodation from the Board employees/making the payment of House Rent Allowance.

3.- The matter has been considered at length and it is clarified as under:-

- i) The pay as defined in Regulation 2.45 of PSEB MSR Vol-I Part-I may be taken into account for the purpose of grant of House Rent Allowance w.e.f. 1.9.88.
- ii) In the revised scales of pay, 5% of the basic pay is to be charged as rent from the PSEB employees provided with Board accommodation w.e.f. 1.4.88.
- iii) In the case of those employees whose scales have not yet been revised, the rent @ 5% for Board's accommodation be charged on the emoluments defined in office order No. 150/Fin/PRC-1988 dated 6.4.89 subject to final adjustment after revision of their pay scales.







Reference your letter No. GAD-FB-89/74 dated the 25th January, 1989 addressed to the Secretary Health and Family Welfare, Punjab and copy enclosed to Secretary Finance, on the subject noted above.

2.- On reconsideration of the matter, the President of India is pleased to decide that the ceiling on Non-Practising Allowance removed vide letter No. 9/242/80-FPI/10553 dated the 16th September, 1987 effective from the 9th August, 1987 shall now be deemed to have been removed notionally from the 1st January, 1986 in the old scale of pay. Consequently this will not involve any payment of arrears in the old scales as the notional removal is only for the purpose of fixation of pay in the revised scales. It has further been decided that the amount of dearness allowance/adhoc dearness allowance admissible on basic pay plus Non-Practising Allowance at old rates shall be counted for the purpose of pay fixation in the revised scales.

3.- Necessary amendment in the Punjab Civil Services (Revised Pay) Rules, 1989 will issue separately.

Subject: SANCTIONING OF PROJECT ALLOWANCE.

The Board, vide its office order No.146/Fin/PRC-1988 dated 20-3-89, sanctioned Project Allowance/Generation Allowance for Ranjit Sagar Dam Project, Shanan Project, etc. at the enhanced rates with effect from 1-3-1989.

2.- The Director Plant Design Dte., PSEB, Ranjit Sagar Dam, Shahpurkandi has intimated that a small range of employees falling in the new basic pay slab of Rs.830 to 910 have been put to financial loss as they are getting Project Allowance lesser than that was being drawn by them in the pre-revised scales.






