



Subject Grant of Dearness Relief to the Pensioners/Family Pensioners of the Government of Punjab beyond the Consumers average price index 608.

Sir/Madam,

I am directed to invite a reference to the Punjab Govt. letter No.16/66/84-IFP-III/5632, dated the 6th June, 1989, issued by this Department and to say that the President of India is pleased to decide that Dearness Relief shall be paid to the Pensioners/Family Pensioners of the Government of Punjab to compensate them for the rise in the cost of living beyond average consumer price Index Level 608 at the following rates with effect from 1st July, 1989, in modification of the rates mentioned in the letter referred to above :-

Pension/Family Pension per month plus adhoc relief admissible upto 1st January, 1986 plus Interim Relief granted with effect from 1st January, 1986 wherever admissible or revised pension/family pension admissible upto CPI 608 as the case may be.	Rate of Dearness Relief per month
i) Not exceeding Rs. 1,750	... 34 per cent of pension/family pension.
ii) Exceeding Rs.1,750 but not exceeding Rs. 3,000	... 25 per cent of pension/family pension subject to a minimum of Rs.595.
iii) Exceeding Rs. 3,000	... 22 per cent of pension/family pension subject to minimum of Rs. 750.

1.2. Payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.

1.3 Other provisions contained in Finance Department letter No.16/66/84-IFP-III/8181, dated the 15th July, 1987, governing the grant of Dearness Relief to the pensioners/family pensioners will remain unchanged.

1.4. A Ready Reckoner showing Dearness Relief payable w.e.f. from 1st July, 1989 onward, in terms of these orders is enclosed.

2.- The expenditure involved will be debitable to the Head "2071- Pension and other Retirement Benefits."

3.- The liability in respect of pre-1st November, 1966 service of the pensioners and their family pensioners shall be divisible amongst the successor States of the erstwhile State of Punjab i.e. Haryana, Himachal Pradesh and Union Territory Chandigarh, in terms of the 1st Schedule of Punjab Reorganisation Act, 1966.



I am directed to invite a reference to paragraph 4.1 of Punjab Government letter No.1/15/89-IFPIII/8078, dated the 31st August, 1989 issued by this Department on the subject cited according to which the maximum limit of the Retirement Gratuity has been raised from Rs.50,000 to Rs.1.00 lac without changing the other existing conditions in this behalf. One of the existing condition for the purpose of grant of D.C.R.G. as laid down in sub rule (5) of Rule 6.16A of Punjab Civil Services, Rules Volume II is that the maximum limit of Emoluments which are to be taken into account for calculating D.C.R.G. shall be Rs. 4000/-.

- 2.- The matter has been reconsidered and the President of India, in partial modification of paragraph 4.1 of letter No.1/15/89-IFP-III/8078 dated the 31st August, 1989 mentioned above is pleased to decide that with effect from the 1st January, 1986 there shall be no maximum limit of Emoluments for the purpose of calculating the Retirement Gratuity.

However, it has been decided that the Ex-gratia grant will be calculated on the revised pay scales w.e.f. 1-1-86 subject to the minimum and maximum limits & other conditions remaining the same.


