

This will not be applicable to the posts of Executive Engineers and Superintending Engineers, as in their case, the revised pay scales of Rs.3000-5600 and Rs.4500-6300 respectively have been determined keeping in view both the time scales and the selection grades.



Subject: Clarification in respect of grant of Proficiency Step-up(s).

Please refer to this office circular Memo No. 210246/896/PRC/Fin-1/1988/L-VI dated 4-10-89 vide which the clarification on Proficiency Step-up(s) (PROP), on the pattern of Punjab Government, were issued. The clarificatory instructions have been challenged in the Punjab & Haryana High Court in Civil Writ Petition No.12318 of 1989 and the Hon'ble High Court have passed the orders for the stay of implementation of point 1(b) of clarification dated 1-9-89 issued by the State Government.

2.- In view of the above, the implementation of point 1(b) of clarifications of circular Memo No.210246/896/PRC/Fin-1/1988/L-VI dated 4-10-89 issued by this office are therefore, hereby stayed till further orders.




